I understand that I am not enrolling my child in a homeschool program, that my child will be an enrolled student of a non-public church-related school, that my home will be designated as a classroom or extension of THE FARM SCHOOL and that at least one parent/guardian will be appointed as a faculty member under the direct supervision of THE FARM SCHOOL'S administration.
- I understand that a learning experience summary should be submitted with this application or within 30 days of enrollment for students enrolling in grades 2-8 who have not attended a public or private school prior to enrolling with THE FARM SCHOOL. Enrollment is probationary until the summary has been submitted.
- I understand a transcript (parent generated is acceptable) should be submitted for high school students (grades 9-12) with this application or within 30 days of enrollment. Enrollment is probationary until the transcript has been submitted.
- I understand high school registration fees are required to receive high school credit.
- I understand that a learning plan / curriculum list should be submitted, preferably with this enrollment application but no later than 30 days after the application has been submitted. Enrollment is probationary until the learning plan / curriculum list has been submitted.
- I understand that parents/guardians and their college-track high school students are responsible for scheduling ACT/SAT/PSAT tests, ensuring that the student earns the credits required for admission to college and researching eligibility requirements for Tennessee lottery scholarships.
- I understand that I must provide proof of immunization or a signed, written statement that such immunization and other preventive measures conflict with my religious tenets and practices, affirmed under the penalties of perjury.
- I understand that attendance and progress / grade reports are required and are to be submitted within 30 days of the end of each semester.
- I understand that THE FARM SCHOOL SATELLITE CAMPUSES PROGRAM will comply with the requirement of TCA 49-6-3007 and that the names, ages, and addresses of all pupils in attendance will be reported to the superintendent of the public school system in which the school is located.
- I understand that the registration fee covers basic administrative processing; additional fees may apply for services such as curriculum consultation, portfolio planning / review, and transcript review.
- I understand this application will not be processed until registration fee is received and has cleared.
- I understand that registration fees are not pro-rated or refundable. Re-enrollment registration fees, if paid on or before Sept 1, 2009, are \$40 per year per student for grade levels K-8, and \$80 per year per student for grade levels 9-12. **After Sept 1, 2009 re-enrollment fees for the 2009/2010 school years are \$45 and \$90, respectively. There is a 20% discount for siblings.**
- I understand that Homeschooling Reporting Online is an optional service **but highly recommended** for families with high school students. I have  have not  included \$10 (per family, not per student) for a Homeschool Reporting Online account to report attendance and progress /grade reports online.
